

The following, which is a summary and not verbatim, is the radio traffic that Kelsey provided to dispatch after the crash:

10:35 a.m. - Deputy Wooldridge advises dispatch "I thought there was a call to the triathlon, there was not, hold off real quick"

10:35 a.m. - Deputy Wooldridge states "I thought there was a call, there was not, I pulled off real quick, I wrecked my vehicle, triathlons are ok, it was just very fast"

10:35 a.m. - Dispatch inquires with Deputy Wooldridge if she is ok, and if they need to send EMS

10:36 a.m. - Deputy Wooldridge says "can you send medical please, Newmansville"

10:36 a.m. - Deputy Wooldridge says "I can't tell you where we are at just yet, give me a second, were ok, thought there was a medical, there is not a medical."

10:36 a.m. - Dispatch asks for the nature of the call, and says they're sending BLS (Basic Life Support) to that location

10:36 a.m. - Deputy Wooldridge advises dispatch "its in the foothills of Newmansville"

10:37 a.m. - Deputy Wooldridge states "there was a vehicle coming on, he went off, he continued on"

10:37 a.m. - Deputy Wooldridge states "I didn't get a look a the vehicle, it just continued on, didn't see the bikers, and continued on to 123"

10:37 a.m. - Dispatch asks Deputy Wooldridge for a description of the vehicle and if she was involved in the crash

10:38 a.m. - Deputy Wooldridge states "negative, I wasn't really involved, I just saw it happen, it just, it happened"

10:38 a.m. - Dispatch asks Sgt. Faulk if they need to be looking for another vehicle that left the scene

10:39 a.m.- Deputy Wooldridge advises, during a lengthy radio transmission that her vehicle is in a field, she cant get to it, and the airbag is deployed. She states there is no injuries and says "it was a vehicle that did not pay attention", she then states "I'll get information here...it was a vehicle that did not pay attention, I avoided the wreck, avoided the bikers, just kept going."

10:39 a.m. - Dispatch asks for a description of the vehicle. Deputy Wooldridge responds that she does not have one.

10:39 a.m. - Deputy Huffman asks Deputy Wooldridge if the vehicle left the scene and she asks him to repeat his traffic. Deputy Huffman asks if the vehicle hit her or someone else and then left.

10:40 a.m. - Deputy Wooldridge responds to Deputy Huffman that the vehicle did not hit her, but that she "hit into the field to avoid it."

10:30 a.m. - Deputy Huffman asks what direction the alleged suspect vehicle was traveling. Deputy Wooldridge does not respond.

10:41 a.m. - Dispatch asks Deputy Wooldridge if she has a last known direction of travel of the alleged suspect vehicle.

10:41 a.m. - Deputy Wooldridge responds "West on 123 Newmansville, or not 123 just Newmansville, west on Newmansville." Her traffic becomes inaudible for a brief period and she then says "I apologize."

10:41 a.m. - Dispatch asks for a description of color of the vehicle, so they can notify Cass County.

10:41 a.m. - Deputy Wooldridge responds "it was a dark colored vehicle, dark blue I think, headed west on Newmansville." "That's all I have, just passed bikers way too fast, I tried to intercept, umm...thats about all that happened."

10:42 a.m. - Deputy Wooldridge says "I was stationed at Rogge turnaround and I saw that vehicle coming in, and I just took off to slow it down, it did not slow down, just kept turning, so I turned off into the field, that's when my vehicle wrecked."

10:42 a.m. - Deputy Wooldridge then asks dispatch to send Sgt. Foulk or the Illinois State Police to her location. Dispatch responds that they have units en route to her location, including Sheriff Oller.
